## How we work:

We can provide as much or as little support as you require. Some clients come to us with a discrete task that they require assistance with and where possible we offer a fixed fee.

Others like to have the ability to contact us as and when needed (without having to open a new file each time). For clients who require ongoing advice, we offer a retainer service. This means that you can purchase a set number of hours of time to be used over a 12-month period. Typically, this ranges from 3, 5 or 10 days and the overall price represents a reduced hourly rate. You have the option of paying in 12 monthly instalments, which works out at roughly £394 plus VAT per month if you purchase 3 days of our time, and you have easy access to solicitors whenever needed.



Our level of involvement depends on your requirements and varies from telephone and email advice, to advising on every stage of the process, which often includes preparing letters and scripts for meetings.
